Valerie Martinez-Ebers is a University Distinguished Research Professor of Political Science and Director of the Latina/o and Mexican American Studies Program at the University of North Texas. She is a former Vice-President of the American Political Science Association and a former President of the Western Political Science Association. From 2012-2016, she served as Co-Editor of the *American Political Science Review*, the flagship journal in political science. Dr. Martinez-Ebers has published widely on education policy, Latino/a politics, and women in politics in outlets such as *American Political Science Review*, *American Journal of Political Science*, and *Journal of Politics*. She is co-author of *Politiclas: Latina Public Officials in Texas* (2008); *Latino Lives in America: Making it Home* (2010), *Latinos in the New Millennium: An Almanac of Opinion, Behavior and Policy Preferences* (2012) and *Human Relations Commissions: Relieving Racial Tensions in the American City* (2020). She also edited *Perspectives on Race, Ethnicity and Religion: Identity Politics in America* (2009), an anthology that examines the history, current issues and dynamics of minority groups in the United States. She was co-principal investigator for the Latino National Survey, an 8,643-respondent, state-stratified survey funded by the Ford, Carnegie, Russell Sage, Hewlett, Joyce, and National Science Foundations.

*Police Reform in America: Empowering Local Communities and Enforcing Change*  
(With Brian Calfano, Diego Esparza and Francisco Ortega)  
Status: Book prospectus and 13,365-word sample chapter currently out for review at University of Michigan Press and New York University Press.

The proposed text is intended to be a highly professionalized best practices study that is aimed at city administrators and local elected officials. The book is based on extensive field research in the local governments of Los Angeles, Cincinnati, and Fort Worth, Texas, along with surveys of community residents and police officers in each city, and an analysis of comparative policies gleaned from other advanced industrialized countries to provide a framework for practitioners and analysts alike in successfully reforming America’s local police forces. More specifically, we (co-authors Brian Calfano and Valerie Martinez-Ebers) have surveyed 1,250 community members and 500 police officers in Cincinnati. We also surveyed 3,991 community residents and 890 police officers in Fort Worth. All the surveys were conducted online using Qualtrics and they



were conducted under the auspices/sponsorship of the office of the Police Monitor in Fort Worth and the office of Citizen Complaint Authority in Cincinnati. We are will soon be in the field with our community resident survey in LA and negotiating the details of our survey with the LAPD.

*“Value of One? Evangelical People of Color and the Politics of Individualism and Social Justice in America”* (with Tony Carey and Brian Calfano)

Status: Book prospectus currently being revised to send back to Temple University Press.

The proposed text examines the variable effects of religious values on the support America’s largest racial/ethnic minority groups have for social welfare policies. Building on elements of both the religion and politics and race and ethnic politics literature, the work leverages a variety of methodological approaches to understand orientations toward government domestic spending among evangelical Christians who are African American and Latina/o. We also include consideration of white evangelicals as a baseline reference group. Our theoretical expectation is that, despite similar challenges in contemporary American politics, African and Latina/o Americans react differently when exposed to religious values that accentuate individualism versus social welfare.

‘Rock n’ Pol: Music’s Impact on Politics and Popular Culture’ (with Brian Calfano)

Status: Book prospectus and one chapter currently being revised to send to Columbia University Press.

Rock n’ Pol examines and explains the influence of popular music on American politics, featuring a breadth of coverage of musical genres, a mixed-methods approach to evaluating musical impact, and written in prose that will be understandable to college students as well as general audiences. Rock n’ Pol is the first comprehensive manuscript examining the relationship between music and politics. While others have produced scholarly monographs providing key historic and analytical insight into portions of the music and politics relationship, our work provides both the broadest coverage of musical genres relating to political phenomena, and features presentation of what is (to our knowledge) the most rigorous research findings establishing musical effects on political outcomes. What is more, the text is written to be accessible to the general reader, and would be of particular use in undergraduate courses in American studies, political science, music and popular culture, sociology, and music history.
