Who We Are:

The U.S. Department of Health and Human Services (HHS), Office of Inspector General (OIG) is the largest inspector general's office in the federal government. Within HHS-OIG, the Office of Investigations (OI) conducts criminal, civil and administrative investigations of fraud and misconduct related to over 100 HHS programs, as well as operations and beneficiaries. State-of-theart tools and technology assist OIG investigators around the country and help OI meet its goal of becoming the world's premier health care law enforcement agency.

OI investigates Medicare and Medicaid fraud; child support enforcement matters; potential illegal activities; and mismanagement by applicants, grantees, contractors, or HHS employees in the performance of their official duties.

OI conducts investigations in all 50 States and its territories and leverages its resources by actively coordinating with the U.S. Department of Justice and other law enforcement partners.

OI is recruiting Student Investigative Analysts through the Pathways Program. There are vacancies available nationwide and these positions will be located in regional and/or field offices.

Investigative Analysts support the Office of Investigations through:

- Conducting research and analysis utilizing state-of-the-art analytical programs, and applications;
- Collecting and producing investigative data, studies, trends, patterns and predictive modeling;
- · Identifying intelligence gaps;
- Reviewing and analyzing a variety of documentation, such as financial records or healthcare claims;
- Participating in various activities to assist in the prevention and investigation of fraud and misconduct related to HHS programs, operations and employees.

Requirements

To be eligible for selection, candidates must meet the following qualifications:

- Fully enrolled in an undergraduate degree program at an accredited college/ university or;
- Recipient of an undergraduate degree and currently enrolled in a graduate program.
- Must be able to complete 640 hours of work experience before graduation.
- At least 18 years of age.
- · United States citizen.
- Must provide official academic transcripts or letter of acceptance and verification of enrollment on school's letterhead
